### IMPORTANT DEADLINES

#### March 24 Registration Form Deadline

All refund, transfer, and cancellation requests cannot be completed online, and must be submitted to the ODA via email to [odc@oregondental.org](mailto:odc@oregondental.org) or written letter received by March 24, 2022. A \$25 handling fee will be charged for all tuition refunds. Registration transfers will be accepted for the same year without penalty. **Refund requests will not be granted for any reason after 11:59 pm on March 24, 2022.**

#### May 14 Virtual Registration Closed

Registration for the virtual program must be completed by 11:59 pm May 14, 2022.
