



# FROM THE EDITOR

# More Than a Filling

#### IT WAS THURSDAY AT 4:45 P.M. AND

my last patient of the day – let's call him Peter – was checking in. If I'm being honest, I was already thinking about changing into my sweatpants and catching up on *The Bachelorette* finale episode when I got home. Peter had chipped tooth #29, and I was planning on doing a simple DO composite. I'd be done in 15, maybe 20 minutes, and home to my couch by 5:30 p.m.

Once I sat down with Peter, though, he disclosed that he had recently been facing some significant family challenges. When I thanked him for sharing that personal information with me, he went on further to say that he didn't really have friends to talk to and he hadn't known who to turn to for support.

At the federally qualified health center I work at, we have begun to integrate oral and behavioral health care. This means that we have a wellness coach with training in trauma-informed care, motivational interviewing, and de-escalation who works full-time in our dental clinic. Our wellness coach supports patients who have dental anxiety, who have barriers to care, and who need to be referred to behavioral health clinicians. Some days, he supports patients with a weighted blanket, headphones, and an essential oil of their choice to reduce anxiety. On Thursday, I asked him to step into the room with Peter. He spent 30 minutes listening to Peter and put together a plan to follow up with a referral to a therapist (which will be covered by his Oregon Health Plan benefits).

I eventually came back into the room and finished up the composite (and made it home by 6:15 p.m. to start *The Bachelorette*). I'm glad that Peter left with that chip on tooth #29 restored. But he needed more than a filling that day. As dentists, we are trained to diagnose maladies of oral health. It is also increasingly important that we take a few

moments to look beyond the teeth and gums to notice what else might be going on. A patient's blood pressure might be elevated, warranting a referral back to their PCP for follow-up. Or we might notice a mole on their cheek that we recommend they talk to a dermatologist about. And increasingly, we examine the patient's airway and discuss issues of sleep apnea with our patients. We may, though, forget to notice their behavioral patterns and mental health.

As our professional and national conversation around mental health and wellness becomes more robust, it is important for this conversation to trickle into your clinical practice as well. Some patients, like Peter, may volunteer that they are struggling. Some, though, might not be so transparent. I would urge us all to consider other, more subtle, cues. Has their oral hygiene declined significantly when they used to be a perfect brusher? Have they missed multiple appointments when they used to be 15 minutes early? Do you notice increased muscle tightness and wear on their teeth? We have the gift of prolonged relationships with our patients, which may mean that we notice mental health changes that other providers do not. Don't be afraid to ask your patients about their mental health and encourage them to seek support. You may not have a wellness coach embedded in your clinic, but you could compile a handout with information on the National Crisis Hotline (dial 988) and the Psychology Today directory of therapists (searchable by location, types of therapy, insurances accepted, and more). Or, maybe, you could just lend a kind and listening ear when they are in your office.



### House of Delegates Resolutions Report

# BOT-1-22: Cost of Living Increase: Passed

Since 2012, the ODA Board of Trustees has submitted annual dues increases for the House of Delegates' consideration in order to be able to continue to provide the same level of valuable programs, with the rising cost of doing business. The House passed BOT-1-22, increasing the 2023 ODA annual dues by \$35.

# BOT-2-22: Streamlining Membership Processing: Passed

BOT-2-22 streamlines the membership application processing method by removing local component review, allowing applications to be processed quicker and directly by the ODA. Local components will be notified once a new member is processed. The House passed BOT-2-22.

# **BOT-3-22: Removal of Outdated Document References: Passed**

BOT-3-22 removes outdated membership processing document references in the ODA bylaws. No substantial change to how membership is processed. The House passed BOT-3-22.

### BOT-4-22: Board of Dentistry Appointment Recommendations: Passed

BOT-4-22 aligns bylaws with current practice by having the Leadership Development Committee make recommendations to the governor's office on Board of Dentistry candidates. The House passed BOT-4-22.

### BOT-5-22: Eliminating Risk Management CE Requirement: Passed

Current bylaws require all ODA members to complete three CE hours of risk management every three years as a condition of membership. This resolution removes the risk management CE requirement as a condition of ODA Membership. The House Passed BOT-5-22.

#### Gubernatorial Candidate Forum

2022 ODA delegates had the unique opportunity to hear from and ask questions of all three candidates vying to be Oregon's next governor: Tina Kotek, Democrat, Betsy Johnson, Unaffiliated, and Christine Drazan, Republican.

Good morning everyone. It is so good to see all your faces on this call today. It is heartwarming and makes me happy to have members engaged and involved on such an important day for our association, board of trustees, and honored guests. Thank you, everyone, for dedicating your time to yet another Zoom call, and for having the fortitude to continue focusing in on all the business and meetings we're conducting today.


What a privilege to have all the gubernatorial candidates come on to our call today; we are so grateful that they will be including us in their busy campaign schedule! This is going to be an exciting race, and we'd love you to ask questions when they are on the call later today.

We worked closely with the board to help regulate final guidelines and saw it come to fruition this past month; licensing for dental therapists is now available in Oregon. ODA's legislative team is incredible, and we are so fortunate to have them. They really do put their whole heart and soul into working for our members on these projects, and it is so encouraging to see the successes we've gained due to their dedication.

This year we were able to have an in-person dental conference, which was extremely well-attended, despite looming concerns of yet another shut down. It was so encouraging to once again see people in person, mingling and connecting. I know that, for me, it felt great to catch up with old friends that I only get to see at this conference.

We continue to navigate an ever-changing landscape of meetings and events to ensure that we, as a board, are exploring all avenues to engage and involve different parts of our state.

Our first CE opportunity in Southern Oregon on November 5th will kick off a series of regional CE events.



This wellness-focused CE is the first of our new concept of short, more topic-focused meetings. We aim to make these a bit different than the CE offerings so readily available from other sources. We do understand that the ODA is not the first place people tend to look for their CE, but it is an integral part of our membership and a good benefit. It is one of the few ways we are able to directly and deeply engage our members. It also allows us a platform where we can share greater understanding of our main objective and mission, which is advocacy.

Unfortunately, lack of growth in our membership numbers is hindering us greatly right now. This means we are capped in our ability to powerfully advocate for ourselves and our patients – our most important goal as an organization. As I address the most critical issues we face today, please seriously consider how you can encourage your colleagues to join us in the fight to protect and support our profession, through the power of the ODA.

As an office owner and full-time working provider, I have an intimate understanding of our workforce issues today, as do you, I'm sure. This is our number one priority moving forward; this is what is affecting every aspect of dental practice modalities. Populations with greatest needs are having even worse access to care because our FQHCs are not able to hire more providers due to a shortage of auxiliary

staff. The Oregon Board of Dentistry recently sent out an email stating that more than 1,000 hygienists in our state have not renewed their licenses. We all know how deeply that will impact our ability to screen patients and establish good overall care for them.

The time is now to use new and creative ways to get people into the dental workforce.

On ODA's long-term legislative track, we can work to recruit early in high school, remove some restrictions to licensing, shorten training programs by eliminating some non-essential requirements, and create bridge and accelerated programs for EFDAs to transition into hygiene.

More immediately, we are working on bills that would provide scholarships for state community college programs to train and license EFDAs, funding for high school programs to train and recruit students for the dental field, and funding for outreach programs to underserved areas.

We need both long-term strategies and rapid fixes, and ODA is proactively addressing this crisis on both fronts.

Our nation, through the pandemic, has come to realize that mental health is a much-needed area of focus. We see it at the ODA, and we have worked to do our part to help our members cope with the toll of the enormous challenges that they sometimes face. The ODA was able to have our members incorporated into the Oregon Wellness Program, which provides confidential and free counseling services to dental providers, without requiring a medical record tracking. We have

now secured more and continuous funding for this incredible benefit; I'm happy to say that it has been utilized well thus far, and I'm even happier to say that this crucially important program will be in place into the future. The pandemic challenges are easing, though the aftermath continues to ripple through our society. And, as we all know, life is what happens while you're making other plans, so it is essential to know that there is a way for each of us to get mental health help when it is needed.

Our last board meeting was focused on strategic planning and forecasting, establishing a clear pathway to helping our patients and providers over the next 3 years. We know that the dental office model is changing, and we must stay relevant for all members, regardless of your practice modality. The board of trustees is committed to building better and stronger relationships with dentists beyond the private practice model. We are ensuring that our legislative agenda incorporates the needs of FQHCs, large group practices, and DSOs, as well as private practice.

It is well known and understood that, these days, moving directly from dental school to private practice is increasingly rare. So, we are dedicated to keeping ODA current with the changing landscape, and connected with students entering the workforce. The best way to do that is through engagement with our existing members in these different models, so we know what you need for your best practices. Please know

this: We want to hear from you; we want to work for you; and we are an organization that can, and will, fit your needs.

As I end my year as president, I'd be remiss if I didn't mention our staff at the ODA. Their service extends far beyond the 8-5 office day, and their dedication, knowledge, and heart for the mission of the Oregon Dental Association goes beyond what you could imagine. I am honored to have had the opportunity to work alongside you as a representative of our board and our members, and I want to extend a huge thank you to you, first and foremost. To the board of trustees, you have been my friends and comrades for a long time now, and it was an honor and privilege to serve you in this role. It has given me so many tools moving forward, and I am sure it won't be long until I find my way back to help out in other roles. # New ODA President Mark Miller, DMD, MAGD

#### MARK MILLER VIVIDLY RECALLS HIS

FIRST TRIP to the dentist, a former military practitioner who had served in World War II and required a bus trip from Miller's childhood home in Aloha to Portland. "He was an old-school dentist who absolutely hated children and scared the daylights out of my brother and me," he said.

Family friends recommended Dr. Dan Johnson in Aloha, whom Dr. Miller credits with saving several of his teeth over the years. During high school, he spent more time with Dr. Johnson and job-shadowed him. "By the time I was in high school, I knew that's what I wanted to do and, along with my parents, he encouraged me to pursue a career in dentistry."

After earning his bachelor's degree at Lewis and Clark College in 1975 and his DMD at the Oregon Health & Science University School of Dentistry in 1979, Dr. Miller started a private general dentistry practice in Carlton. The practice grew over the years and, in 2004, he built a bigger office and renamed his practice Carlton Dental.

Dr. Miller said his favorite aspect of private practice was meeting people and volunteering in the community, including serving as president of the Chamber of Commerce, chair of the Yamhill County Board of Health and chair of the planning commission. He also coached everything from tee-ball, softball, and soccer to high school basketball and baseball for many years.

"I got to know a lot of families, and I enjoyed seeing my patients outside of the office and hanging out at barbeques when they weren't stressed," he said with a laugh, noting he had treated three generations of some families by the time he retired from his practice in 2015.

In 2017, he volunteered to teach at OHSU before becoming an assistant professor of

restorative dentistry. He teaches Mondays through Thursdays and mostly works with third- and fourth-year students in the predoctoral program.

"Some blossom right away and, for others, it may take a year for concepts to sink in, but you get to watch them grow, and it's fun to see when the light goes on," he said. "I love the interaction we have, and the students are awesome. I always look forward to going to school on Monday. We are fortunate to have an outstanding faculty and staff, and the facility is very impressive."

Dr. Miller credits the late Bernie Taylor, longtime executive director of the Oregon Academy of General Dentistry, with introducing him to the importance of organized dentistry by encouraging him to get involved in a study group while he was in dental school. He continues to participate in the Alpha Omega Study Club, which is affiliated with the Seattle Study Club.

"Organized dentistry is the voice of dentistry, and we have to realize that. I'm not into politics, but we need to have advocates and a voice for the profession," he said, adding the profession has had to dispel the perception that all dentists are wealthy and, therefore, ODA members should pay higher taxes on their practices. "We have great lobbyists in Salem, and without them we would be lost."

While the COVID pandemic shut down ODA activities and other social gatherings, Dr. Miller applauds the return to in-person

events and noted their importance to people's mental health. As ODA's incoming president, he pointed to its Wellness Committee, of which he is a member, and the Wellness Initiative. He talked about their importance to him personally since his wife Linda, his high-school sweetheart, died four years ago.

"I meet once a week with my therapist and I have since Linda passed away. It's such a part of my life now," he said. "Everybody on the committee has had tragedy in life and we're all in this together." Dr. Miller also does impressionistic painting weekly with two of his class of '79 classmates as another source of wellness work.

ODA's Wellness Initiative provides up to eight complimentary counseling sessions for all dentists in the state, whether they are ODA members or not.

Dr. Miller's goals as ODA president also include encouraging more young dentists to get involved by making sure fees are affordable, promoting understanding of the short- and long-term benefits of organized dentistry, and increasing diversity, equity, and inclusion among members.

In addition, with the help of the board of trustees, he plans to address the dental profession's workforce shortage by making education more accessible, encouraging mentorship and advocating for better collaboration among assistants, hygienists and dentists. Dr. Miller is working to form a partnership between OHSU's School of
